Retiree News

Dear Fellow Retiree:

There are several developments since my last communication.

First, Kaiser Aluminum announced on October 26 that the Bankruptcy Court conditionally approved the seventh amendment to the company's Post-Petition Credit Agreement, subject to the lenders agreeing to modify the latest date upon which Kaiser might file a Plan of Reorganization. The Court's required modification would change the specified date for Kaiser to file its Plan of Reorganization to no later than February 13, 2005 (the date the Post-Petition Credit Agreement is presently scheduled to expire), from the previously set date of December 31, 2004.

Second, the company also announced on October 26 that the Court approved another extension of the period of exclusivity for filing its reorganization plan - this one to February 28, 2005.

Third, the company informed us that it plans to send out, on November 5, open enrollment forms to all those retirees who previously selected COBRA coverage. Therefore, those who currently have COBRA should probably have received the forms by the time you read this newsletter. Forms need to be returned no later than December 1. We expect the new rates will be significantly higher than current rates.

Fourth, with respect to the Kaiser Aluminum Salaried Retirees VEBA, the Trust continues to receive cash advances of \$300,000 each month under the terms of the January 29, 2004, settlement and subsequent amendment approved by the Bankruptcy Court. Including an initial advance payment of \$200,000 and monthly payments of \$300,000 for the months of June through October, the cumulative amount received stands at \$1.7 million.

As stated in my message in the September newsletter, it continues to be uncertain when the company may emerge from bankruptcy, how large its initial contribution obligation may be, how much the Salaried Retirees VEBA Trust may receive by way of monthly ad-

vances in the meantime, and the degree to which Kaiser Aluminum may be profitable and in a position to make variable profit-sharing contributions following emergence from bankruptcy. Costs to be incurred in connection with setting up and administering the VEBA Trust and Plan have yet to be ascertained as well. Therefore, it is too early to determine either the amount or the timing of benefits that may be paid under the VEBA Plan. It may not be possible to do so (at least initially) until after Kaiser either successfully emerges from bankruptcy or fails to do so.

The hope is - but there can be no guarantee - that, after providing for current and future operating expenses, there will be sufficient funds in the VEBA to provide limited reimbursement of health insurance premiums (excluding co-payments and deductibles) paid under a health care plan (including Medicare Part B premiums). Also as stated previously, any such reimbursement would be limited to a dollar amount per retiree (including spouse and dependents), so that all eligible retirees under the VEBA Plan would be treated equally. You will be receiving a Summary Plan Description of the VEBA Plan along with the VEBA enrollment materials at such time as the trustees determine there are sufficient funds in the Trust to pay at least an initial benefit.

A concluding observation: All of us were, to put it mildly, disappointed when the company failed to keep its promises with respect to retiree medical coverage. We felt anger . . . betrayal . . . you name it. However, it is important for each of us to remember that it continues to be in our best interests to have the company emerge from bankruptcy as an ongoing, successful entity. To the extent that it does - if it does - the VEBA Trust may be among the beneficiaries in the future.

The next issue of KASRA News won't appear until January. Therefore, on behalf of the board of KASRA, our very best wishes to each of you and your families for Thanksgiving, the Christmas holidays, and the New Year.

sary celebration held in October.

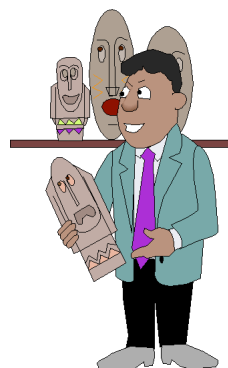

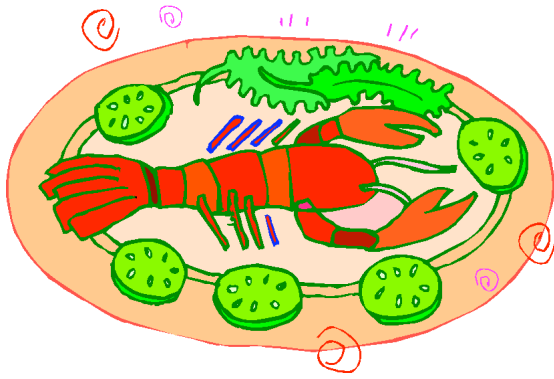
