# Retiree News

## Dear Fellow Retiree:

One of **KASRA**'s major efforts over the past couple of years has been to get information about the VEBA benefits to all salaried retirees and surviving spouses who are eligible for medical premium reimbursements. Once retirees have the information and understand fully their entitlement to the benefit, they can decide whether they want to take advantage of it. However, a point I keep making is that there is no reason not to enroll in the VEBA; only after enrolling can a person apply for the reimbursements they likely are entitled to receive. Currently 82% of our retirees have signed up for the VEBA benefit. This month we are sending a letter to all those who have not yet enrolled, once again reminding them to review the possible benefits that are available to them. A copy of that letter is included in this Newsletter. Our goal is to make sure that everyone who is eligible for VEBA benefits is reached. So, if you know any retirees who have not signed up for the VEBA, please share this letter with them.

Many people have asked what the VEBA reimbursement is going to be for 2007. As you know, it was \$500 in 2005 and \$1,500 in 2006. The VEBA Trustees have not yet finalized the 2007 number but plan to send out a mailing in August, stating the amount and enclosing the form necessary to claim medical premium reimbursement up to that amount. Between now and then, the VEBA Trustees will also send out the 2006 Summary Annual Report to all participants.

Again this year, we are mailing copies of the July newsletter to ALL retirees and surviving spouses – not just **KASRA** members. However, in order to continue to receive copies of the newsletter, you need to be a member of **KASRA**. So, if you are

not already a member, you will need to pay the \$10 annual dues to join.

Enclosed is a "What's Going On" form in which we encourage you to provide updated information about yourself to be considered for publication in the newsletter, a form to use in paying your dues if they are now due for renewal or if you desire to become a member, and a reply envelope. If your current dues are already paid, a dues notice is not included.

Also enclosed (for those who are dues-paying **KASRA** members) is a ballot for the election of directors, which we ask that you complete and return as soon as you can.

I want to close this letter with a request. Please tell me whether or not you feel the **KASRA** organization is meeting your needs and desires. If it isn't, please indicate how we can better serve you.

retiree **Dudley Aldous** (Santa Cruz, CA) took a two-month trip to New Zealand last year, revisiting a place where he once worked.

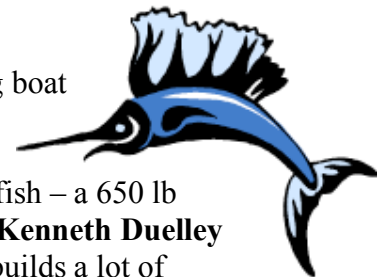

## **Member Profile: Dave Perry**

Thanks to Dave Perry and a number of other KASRA members, salaried retirees and surviving spouses who qualify are receiving benefits to help pay for healthcare expenses. These benefits are funded by a trust known as a Voluntary Employees' Beneficiary Association or VEBA. The following interview recaps its development.

**Q. Kaiser Aluminum filed for bankruptcy in 2002. Kaiser was seeking to eliminate salaried retiree medical and life insurance benefits. What did KASRA do?**

A. We formed a Retirees' Committee comprised of Jed Daniel, Jess Erickson, Jim Hobby, Tim Preece and myself. We engaged legal counsel and requested the Bankruptcy Court to recognize us an official committee so that we could represent salaried retirees and hopefully negotiate a settlement that would preserve at least some of their benefits.

**Q. What was the outcome?**

A. We were initially opposed by Kaiser and turned down by the Bankruptcy Court. But when the corporation distributed an extremely confusing document to salaried retirees regarding the exercise of their COBRA rights, we submitted it to Bankruptcy Court Judge Judith Fitzgerald to demonstrate why salaried retirees needed official representation. Judge Fitzgerald declared she couldn't understand the document either and granted us the right to represent salaried retirees as an official committee exclusively on the COBRA issue. Later on, when it became clear that Kaiser had to negotiate a settlement with salaried retirees over the eventual termination of salaried retiree medical and life insurance benefits, we were recognized as the official committee for that purpose as well. We began negotiations in 2003. The VEBA was established as a result.

**Q. How long did this process take?**

A. We agreed to a settlement in January 2004 that provided for the termination of retiree medical and life insurance benefits as of May 31<sup>st</sup>. Changes to the settlement were agreed upon from time to time during Kaiser's bankruptcy proceedings, with the final terms being agreed to in January 2006.

**Q. How is the VEBA funded?**

A. Kaiser agreed to make certain cash contributions to the VEBA during Kaiser's bankruptcy proceedings against an initial cash contribution obligation of \$5.2 million. Its actual cash contributions during that period amounted to \$7.7 million. Kaiser also agreed to create a profit sharing plan on emergence from bankruptcy and to make variable annual contributions to the VEBA not exceeding \$2.9 million per year, based on its future profitability. Under the settlement, Kaiser was obligated to contribute to the VEBA 1,940,100 shares of Kaiser Aluminum Corporation common stock on emergence from bankruptcy. The VEBA sold its rights to receive a portion of those shares prior to emergence and the balance afterward.

**Q. Who is eligible to participate in VEBA?**

A. Salaried retirees of Kaiser who began service prior to February 1, 2002 and who in retirement are eligible to participate. When an eligible retiree dies, his or her surviving spouse continues to be eligible to participate. Approximately 4200 salaried retirees and surviving spouses are currently eligible to participate and about 82% of those are enrolled. Despite our efforts to communicate with them via mail, there are about 740 retirees or surviving spouses who should be receiving VEBA benefits but haven't yet signed up. We need KASRA members' help in reaching out to these folks to let them know that our correspondence is legitimate and they are entitled to benefits.

**Q. How much money is in the VEBA today?**

A. As of December, 2006, the VEBA had assets of more than \$77 million.

**Q. After 23 years, you retired from Kaiser Aluminum in 1992 as Corporate Vice President and General Counsel. What were some of the professional challenges you experienced during your career?**

A. I worked on a number of projects such as the Celestite-Strontium Carbonate Project in Nova Scotia, the Kaiser-Preussag Joint Venture in Europe, the Kaiser-Aetna Real Estate Joint Venture and the LNG Shipbuilding Project. After I became General Counsel, I was very involved with the three corporate takeover battles of the 1980s.

**Q. What was among the most memorable conversations you've ever had with Chairman and CEO Cornell Maier?**

A. In 1984, Cornell asked me to stay behind as others left a meeting that had just concluded. He asked if I had any champagne in my refrigerator. A very strange question, so I thought at the time. As a matter of fact, I do, I replied, wondering what he would say next. Well, he smiled, you're going to be opening it tonight because the Board has just appointed you General Counsel.

**Q. What are you doing these days?**

A. I am planning a trip to Strasbourg and Paris, France in September. It's actually a high school reunion put together by a foreign exchange student who spent his senior year at my high school in Dedham, MA. We'll be going on a two-week sailing adventure.

Dear Fellow Kaiser Aluminum Salaried Retiree or  
Surviving Spouse:

I am Dick Kauffman, president of the Kaiser  
Aluminum Salaried Retirees' Association  
(KASRA), and I am writing to you on a very  
important matter. You are entitled to reimbursement  
of a portion of your health care premiums each year,  
but only if you enroll in the Kaiser Aluminum  
Salaried Retirees VEBA Plan – VEBA, for short. A  
large majority of Kaiser retirees/surviving spouses  
have enrolled, but we believe you have not.

**There is no reason not to enroll in the VEBA.**

There is no cost to you and you need to enroll only  
once. Once enrolled, the process of filing annual  
claims for reimbursement is very straightforward  
and simple.


More than 80% of your fellow retirees/surviving  
spouses have already benefited from this ongoing  
plan. Those who enrolled and filed claims for the  
year of 2005 – VEBA's first year of operation --  
received reimbursements of up to \$500. For 2006,  
the maximum reimbursement was increased to  
\$1,500. Although you are not eligible to claim these  
past amounts, you can and should enroll before the  
end of this year so you can file claims for 2007 and  
future years.

In talking with retirees, others and I have found that  
some believe they have no medical insurance costs  
to claim. Therefore, they conclude they are not  
entitled to seek reimbursement. In all likelihood,  
that conclusion is not correct. For instance, a retiree  
who has Medicare Part B medical coverage has the  
monthly premium for that coverage deducted from  
his or her Social Security check. That premium for  
Medicare Part B qualifies as a medical expense,  
which the VEBA will reimburse.

You may not have enrolled in the VEBA previously  
because you did not fully understand the plan,  
missed the initial 2005 deadline, thought you  
weren't eligible, or simply didn't get around to  
doing it. To assist you in understanding the plan and  
the process of signing up and claiming  
reimbursements, I encourage you – or a close friend  
or family member --to contact any one of the Kaiser  
retirees listed on the following page. If you prefer,  
fill out the enclosed post card and send it back to  
**KASRA** and you will be contacted by one of us.  
You do not have to be a member of KASRA to  
enroll in the VEBA or to gain a full understanding  
of it. **KASRA's** only motivation is to make sure you  
know about this reimbursement plan and to assist  
you in enrolling, if you desire.

Again, there is no cost to you. This is a benefit you  
or your spouse earned. So, please contact one of us  
so we can answer any questions you may have.

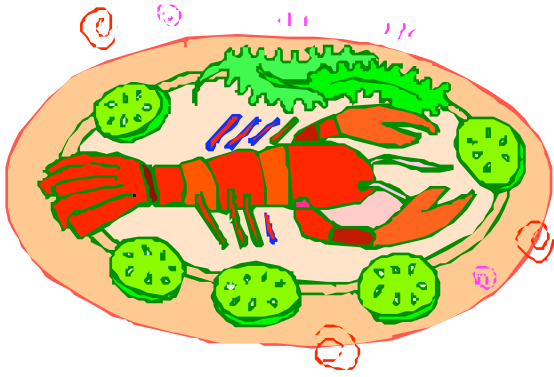
