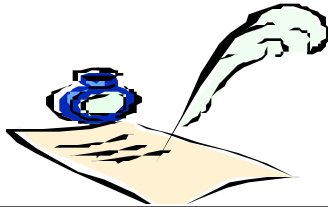

## Retiree News

### Dear Fellow Retiree:

There have been several developments of interest since you received the March issue of the newsletter.

The Bankruptcy Court held a hearing on April 17th to resolve objections by the Pension Benefit Guarantee Corporation (PBGC), the Hourly Retirees' VEBA and the Salaried Retirees' Committee. The objections were to a motion by the company to preclude the PBGC, the Hourly Retirees' VEBA and the Salaried Retirees' VEBA from entering into any agreement to sell, transfer or exchange all or any portion of their claims or rights to distributions under the company's Joint Plan of Reorganization (POR) without the prior approval of the Bankruptcy Court, including their rights to receive shares of common stock in the reorganized Kaiser Aluminum Corporation (KAC). You may recall that the Salaried Retirees' VEBA is entitled to receive 1,940,100 shares, or 9.7%, of the common stock in KAC upon the effective date of the POR. While certain limitations on the sale, transfer or exchange of KAC stock had been agreed to and provided for in the POR following its effective date, no such limitations had been agreed to or provided for during the period prior to the effective date of the POR. The PBGC, the Hourly Retirees' VEBA and the Retirees' Committee opposed the company's efforts to unilaterally impose terms and conditions that had not been agreed to in the various settlement agreements with the company. The matter was settled among the parties under a Protocol approved by the Bankruptcy Court. The Protocol will allow the Salaried Retirees' VEBA to sell and transfer up to 33% (640,233 shares) of its interest in KAC prior to the effective date of the POR, should the Trustees of the Salaried Retirees' VEBA elect to do so.

The company's reorganization proceedings

are continuing. The Bankruptcy Court Order confirming the POR is now before the Federal District Court for approval at a hearing scheduled for May 11th. Carriers insuring the company's asbestos and silica tort claim liabilities continue to oppose confirmation of the POR and it is unclear how long it might take to finally resolve the matter. If the Federal District Court overrules the insurance carriers' objections to the POR as the Bankruptcy Court did earlier, the insurance carriers may still appeal that decision to the United States Court of Appeals for the Third Circuit. We will continue to inform you of developments as they occur.

With respect to the Salaried Retirees' VEBA, you may be interested in the following. As of the 2005 enrollment deadline, 3,819 individuals were eligible to participate in the VEBA Plan and a total of 2,376 had enrolled. Benefits paid during 2005 amounted to \$502,926. Another \$250,769 in claims that were pending but not paid prior to year-end 2005, were paid in January. Participants enrolled in the VEBA Plan prior to the 2005 enrollment deadline have until December 31, 2006 to claim their benefits to the extent that they have not already done so. Net assets available for benefits (cash, investments and interest receivable) as of December 31, 2005 under the VEBA Plan amounted to \$5,491,215. An audit of the 2005 financial statements for the VEBA Plan is underway as is the preparation of various filings that need to be made with governmental agencies. When those activities are complete, expected by mid-year, the Trustees of the Salaried Retirees' VEBA will be mailing an annual report together with a copy of the audited financial statements to salaried retirees. About the same time, the Trustees of the Salaried Retirees' VEBA expect to mail enrollment forms to all eligible individuals who have not yet enrolled and to send out information and materials on the 2006 benefit program.

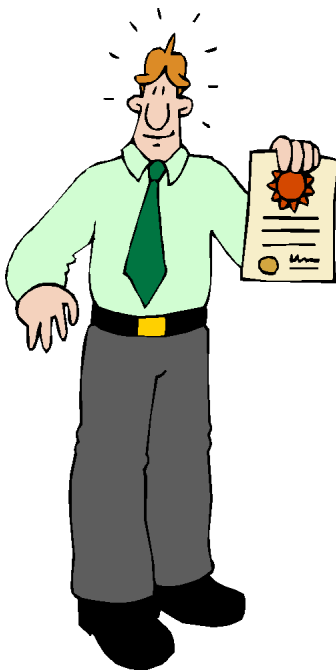
## What's Going On

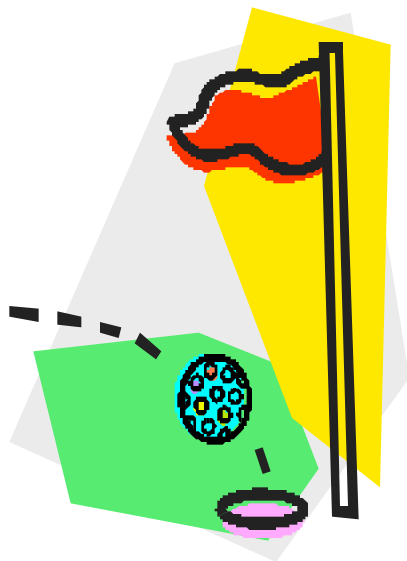

**Reminder: You must be enrolled in the VEBA Plan in order to claim any reimbursement benefits. If you are eligible to enroll in the VEBA Plan but did not do so in 2005, you must enroll before the end of 2006 in order to claim any benefit that may be declared for 2006. If you enrolled in 2005, you do not need to re-enroll.**


The company contributed a total of \$5,900,000 to the Salaried Retirees' VEBA prior to year-end 2005, thus fully satisfying its initial cash contribution obligation of \$5,220,000 under the Settlement Agreement. The Settlement Agreement provides, however, for the company to continue to make cash advances to the Salaried Retirees' VEBA in an amount equal to \$300,000 for each full month that the company remains in reorganization proceedings. Contributions now total \$7,100,000 through April of this year. The excess of these advances over the company's initial cash contribution obligation (now amounting to \$1,880,000) is to be applied as a credit against any profit sharing contributions to which the Salaried Retirees' VEBA may become entitled after KAC's POR becomes effective. The company reimbursed the Salaried Retirees' VEBA for a portion of its administrative expenses incurred in 2004 and 2005 in the total amount of \$108,750. Under the Settlement Agreement, the company is obligated to reimburse the Salaried Retirees' VEBA for up to one-half of its administrative expenses, but not more than \$36,250 in such expenses, for 2006 and each subsequent year.

The VEBA is losing one of its founding Trustees but gaining a talented replacement. Jim Hobby, who along with Dave Perry and Doug Allen, has served as a Trustee since the inception of the Salaried Retirees' VEBA, asked to step down at the end of March this year in order to reduce the number of his commitments. Jim will, however, continue to serve as a member of the Retirees' Committee until the company's reorganization proceedings have been concluded. Joining Dave and Doug on the Board of Trustees of the Salaried Retirees' VEBA is Art Donaldson. Our heartfelt thanks to Jim for his dedicated service and to Art, who has been a valued KASRA board member, for his willingness to assume the responsibilities of a Trustee of the Salaried Retirees' VEBA.

I'll conclude with another reminder: The most timely and cost-effective way of communicating with our family of retirees is by e-mail. If you use e-mail but have not provided us with your e-mail address, please do so. If you are already receiving the newsletter via e-mail, you don't need to do anything except let us know when and if that e-mail address changes. Of course, if you do not have access to e-mail, we will continue to mail the newsletter to you.

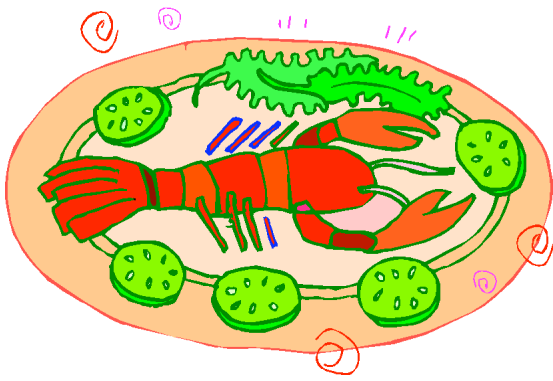
