Q. Why was the web site created?



Q. You developed and created www.e-kasra.com. Were you experienced in designing web sites?

A. Web development and design was an area entirely new to me. Once I had the approval of the KASRA Board, I began researching the subject and began the layout and design effort. Although I initially anticipated having outside resources to advance the effort, I ultimately elected to complete the design by myself, as well as provide ongoing support and upgrades to the site, to keep costs to a minimum. The total effort ended up taking me several months to implement.

Q. Describe the content on www.e-kasra.com

A. When you first enter the site, you see the Home page, which contains general information about the KASRA organization and provides a feedback form for suggestions or comments. I encourage KASRA members to send in their feedback. The remaining six pages cover News & Communications, Events, Newsletter archives, Photos, Forms, and Contact information. Some of these pages have sub pages. For example the News & Communications page includes sub pages for VEBA, KASRA, and Aluminum industry News as well as a link to the Kaiser Aluminum web site.

Q. You maintain and regularly refresh the web site content. How can members assist you in making the website even better?

A. The photos section is one of the most frequently viewed areas on the site. It currently displays pictures from past luncheon gatherings from the Bay Area,

Chalmette, Mead and Tacoma. I thank our current contributors and encourage greater participation from our other locations as well. In addition, I would appreciate receiving timely communications about luncheon dates and details to help keep the information current and accurate.

Q. How many of our members or viewers visit www.e-kasra.com?


A. Over the past year, the site has experienced significant viewership. The photo section receives by far the greatest 'hits', although other pages are frequently viewed as well.

QUESTIONS ANSWERED ON VEBA & KASRA FUNDS

The KASRA Board recently received a question from one of the field locations which may be of interest to many of you. So, I thought I should share the question and responses with all of you. *(The question has been slightly reworded).*

Question

We are a group of nine KASRA members, six of whom are 80+ years of age. We receive information that reports VEBA totals of \$73 million and KASRA resources of \$400,000. Repeated requests have been made to be advised how this money will be distributed in keeping with the increasing age of the members. While the interest on the money continues to increase, the obituary lists are lengthening as well. What do the actuarial tables indicate for our membership population?

The distributions made to date are appreciated, but we suffered some very severe losses when the company went bankrupt and we lost our life insurance and medical coverage. A little knowledge can be a dangerous thing, so please get us up to speed on what the immediate future holds. Thanks.

VEBA Response

As you know, the VEBA is managed by an independent Board of Trustees and not by KASRA. I referred the VEBA portion of your question to Dave Perry, one of the VEBA Trustees. He indicates that, in setting up the VEBA, it was (and still is) the intention to provide lifetime medical benefits to all eligible salaried retirees of Kaiser and their eligible spouses and dependents. The VEBA Trustees commission an actuarial study each year based upon the expected lives of all eligible participants in order to set the maximum reimbursement benefit level for that year. The study is complex

and takes a number of factors into consideration, including the assets in the VEBA Trust, estimated future contributions by Kaiser under the Profit Sharing Plan, estimated future income on the assets of the Trust, estimated future inflation rates, mortality tables, VEBA operating expenses, actual (and estimated future) number of eligible individuals enrolled and participating in the VEBA Plan, and the extent to which enrolled individuals claim the full amount of the benefits available to them. The most recent actuarial study projects benefit payments only out to 2057, but it is expected that some eligible individuals will live longer than that. **The current objective is to pay sustainable annual benefits out of principal and income in such a manner that no funds remain for the payment of benefits and operating expenses after the last individual eligible for benefits is no longer living.**

KASRA Response

With respect to the resources which have been accumulated by KASRA, the KASRA board has voted to continue to carry out the primary purpose of KASRA's Articles of Association and By-Laws, which is to maintain and promote the interests of the salaried retirees of the company.

Now that we have settled with the company on the benefit issues through formation of the VEBA, KASRA's primary focus is membership communications through its newsletters published six times a year, e-mail notices, and maintaining both a telephone hotline and the KASRA website. In addition, we maintain both a roster of members to enable us to carry out these functions.

KASRA's current activities cost approximately \$50,000 a year. Unpaid, volunteer board members provide a number of services to KASRA, but with the passage of time we anticipate it will necessary to employ outside help for at least some of these services. In addition, there may be unforeseen legal expenses. It is the current intention of the Board to fund these expenses through the existing cash reserves and membership dues. As you know, we have reduced the annual dues for members. While the VEBA is projecting its program to go through the year 2057, nearly 50 years from now, it is highly unlikely KASRA will exist that long.

In summary, KASRA currently plans to continue to provide the above-mentioned services without increasing dues to members. The Articles of Association and the By-laws do provide for a distribution process if KASRA is dissolved. The Board currently has no plans to make any interim distribution of cash to its members.
