A MESSAGE FROM KASRA PRESIDENT

Dear Fellow Retiree/Surviving Spouse

The response to our annual drive for membership renewal was excellent. A large number of you have returned the "What's Going On" form advising us of activities during your retirement and semi-retirement years. Some of these will find their way into our newsletter or, if too numerous to be accommodated there, possibly onto our website.

As previously indicated, the annual drive in July is our attempt to reach out to all our salaried retirees. I use this term "retirees" loosely as some of our members are still working full-time elsewhere and others, though now retired, did not retire directly from Kaiser. Although the majority of KASRA members are eligible for VEBA benefits, there are some who do not qualify but still remain members of KASRA. Our Bylaws, under Article 4.1.1, clearly state that any person who is a former salaried employee of the company or who is a spouse or other dependent of a disabled or deceased former salaried employee of the company is eligible for KASRA membership. We have only one class of member and one can belong by simply paying our current annual dues of \$10. Stated simply, KASRA is essentially a salaried alumni organization, regardless of time spent at Kaiser.

Some of the advantages of membership are the opportunity it affords to communicate with each other; being informed periodically about our remaining benefits; learning about the activities of fellow alumni; and enjoying each other's company at the various "lunch bunch" functions across the country. In regard to the latter, more pictures of these gatherings are requested and welcomed for the newsletter and website. Currently, photos of the Bay

Area, Chalmette, Mead, Ravenswood and Tacoma are posted on our KASRA website (www.e-kasra.com). We welcome pictures from other areas.

In the previous issue, I mentioned some of the people who are involved in the newsletter. 

MEMBER PROFILE: Lee Corder

In 1965 Lee Corder and his wife, Sue Ann, moved from Salem, WV to Ravenswood to begin their lives as newlywed schoolteachers. Three years later, Lee left teaching and joined Kaiser Aluminum's Ravenswood Works as an inspection clerk in production control. He spent his entire 34-year career in the aluminum industry there, although not all that time under Kaiser ownership. In 1989, after 21 years with Kaiser, Lee found himself working for newly formed Ravenswood Aluminum and continued to work there until 1996 when the plant was sold to Century Aluminum. He continued at Century until its 1999 acquisition by Pechiney SA. Lee officially retired in 2002, one year before Pechiney was acquired by Alcan (Rio Tinto 2007). He and Sue Ann still reside in Ravenswood in the same home they've had for more than 40 years. He serves as President of the Ravenswood Retirees Association.

Q, What was the most memorable experience you had while working for Kaiser?

A. I recall a couple of challenging and rewarding projects. The first was learning to make can stock and supplying Kaiser's three can plants, as well as major companies like National Can, Ball Metal and Coors. The other experience was called the Kawasaki Project, an

LNG (liquefied natural gas) program.

The corporation had a contract to make an e-ring to put around LNG tanks. At first it was a partial contract, but when the original contractor dropped out of the project, Kaiser ended up making the whole tank as well as the e-ring.

Q. You've worked at the same plant over the course of your entire career in the aluminum industry, while Ravenswood has undergone several ownership changes. How would you characterize your Kaiser Aluminum experience?

A. West Virginians consider Ravenswood to be Kaiser's flagship plant, and I dearly loved working for such a great company and for such knowledgeable, sharp and sincere people at Kaiser. We worked hard and we played hard, socialized like we were family at spring cookouts, steak fry get togethers and office Christmas parties.


Q. Describe your KASRA involvement.


VETERANS PENSION BENEFIT FOR ASSISTED LIVING

Cleveland wire and cable retiree **Clarence Smith** of Medina, OH, called KASRA recently to share information about a benefit program available to veterans. Disabled or qualified older veterans and their surviving spouses may be eligible for a VA "Aid and Attendance" disability pension benefit to subsidize caregiver or assisted living expenses.

Smith was made aware of the program during his own research on assisted living facilities in his area. "I was diagnosed with diabetes a few months ago, and wanted to look into assisted living," he says. The 81-year old found the Camelot, a local facility that told him about the VA benefit and which also provides an ombudsman to help prospective qualified residents through the VA application process. According to Smith, income and assets must be limited to determine eligibility. "If I qualify, I could get \$1644 a month in assisted

living subsidy," Smith said. He suggests that interested veterans or their surviving spouses enlist the help of a relative to be their advocate. "Or call around to find a local facility with an ombudsman," he added.

The "Aid and Attendance" disability benefit is associated with VA Pension Income. It is separate and distinct from the VA's service-connected disability benefit administered as Compensation Income. For clarification and eligibility requirements, please contact your local VA office. Or, call VA National toll free at (800) 827-1000. Click www.va.gov to visit the VA website. For those who surf the internet, please note that certain web sites which promote this benefit may be private financial firms not associated with the government or with the VA. These firms charge fees for application services. Be sure to read the fine print and disclaimers.
