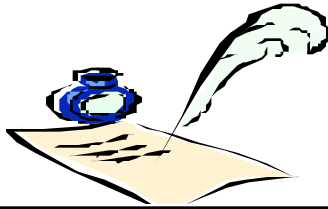

## Retiree News

### Dear Fellow Retiree:

You will be receiving this issue of KASRA Retiree News a little later than usual because we wanted to provide the latest information on the VEBA and other matters.

With respect to the VEBA, **if you are eligible to enroll but have not yet done so, please do it now.** You need to mail your completed VEBA enrollment form so that it is received prior to December 31, 2005. It should be mailed to Thomas P. Corcoran, Professional Insurance Consultants, Inc., P. O. Box 4026, Concord, CA 94524. Do not mail your enrollment form to KASRA.

Included in this issue of the newsletter is an updated communication on COBRA/Bankruptcy Cobra and the VEBA that was first e-mailed on September 30 to those KASRA members who have provided us with their e-mail address. It explains why those who elected to receive and are receiving COBRA or Bankruptcy COBRA are not eligible to participate in the VEBA Plan at this time. We have received a number of questions on this subject.

Also included in this issue is a communication we sent via e-mail on September 28 aimed at helping retirees who had lost important records, including documents related to the VEBA Plan, as a result of the Gulf Coast hurricanes. This communication provides contact numbers to obtain replacement records as well as numbers to inquire about any missing PBGC pension checks or to check to see if any COBRA premium payments you mailed were received during that catastrophic period.

As you know from previous newsletter messages, so long as Kaiser Aluminum remains in Chapter 11 reorganization, it is obliged to make advances of \$300,000 a month to the VEBA Trust. Including an initial \$200,000 advance payment, the advances to the Trust through October total \$5,300,000. The agree-

ment establishing the VEBA Trust provided, among other things, that if the company made advances of more than \$5,220,000 before emerging from bankruptcy, the excess contributions would be credited and offset against future profit-sharing contributions, if any. Including the October payment, the VEBA has now exceeded that threshold. It is our understanding that the company now plans to emerge from Chapter 11 some time in the first quarter of next year.

A reminder: If you use e-mail but have not provided us with your e-mail address, please do so. That will ensure you receive communications in the most timely manner.

Recently, KASRA has received some questions concerning the various prescription drug options retirees may have under Medicare Part D. KASRA is not in a position to provide you guidance except to refer you to the new handbook, "Medicare & You - 2006" recently issued by the Centers for Medicare and Medicare Services. You should have received a copy of this handbook in the mail by now. It provides a very good outline of the new Medicare prescription drug benefits and the options you may have. If you have questions about your Medicare prescription drug benefit options after reading this material, you may obtain additional information on the Internet at [www.medicare.gov](http://www.medicare.gov) or by calling 1-800-633-4227.

In closing, I want to reiterate that our thoughts and prayers continue to go out to our retirees and to the many others outside of our retiree family who were impacted by Katrina, Rita and Wilma.

### Dear Retirees and Surviving Spouses:

A number of Kaiser retirees and surviving spouses living in the Gulf Coast region have experienced firsthand the kind of horror and loss that others of us can only imagine. Our thoughts and prayers go out to them and to the many others outside of our retiree family who were impacted.

In the aftermath of Katrina, we have learned from some retirees that they lost many of their important

records, including documents relating to the Kaiser Aluminum Salaried Retirees VEBA Plan. If you have need of replacement documents relating to the VEBA you should call the VEBA Plan's Third Party Administrator at 800-339-3479 (in California only) or 925-798-2550 (outside of California). The VEBA mailing went out to all salaried retirees/surviving spouses except those who signed up for COBRA medical coverage. Retirees receiving COBRA health care continuation coverage from Kaiser are not eligible for VEBA enrollment while covered by COBRA. Eligible retirees/surviving spouses have until the end of this year to enroll in the VEBA. Then you have until the end of 2006 to submit your request for reimbursement of up to \$500 in health care premiums paid per family unit in 2005.

If you elected to receive group medical benefit continuation coverage from Kaiser Aluminum under COBRA or Bankruptcy COBRA and if you are in doubt about whether your premium payments have been received (or any questions concerning your coverage), you should call EBDS at 877-794-4446 8:00 AM - 6:00 PM Eastern time.

If you are missing any pension checks resulting from hurricane-caused disruptions, you should call the U.S. Government's Pension Benefit Guaranty Corporation at 800-400-7242 if your pension payments have been assumed by the PBGC. If your pension payments are still being made by Kaiser, call Kaiser at 949-614-1766.

If, after calling the above numbers, you experience difficulty in validating a COBRA payment and/or receiving a lost pension check, email us at [kasra@e-kasra.com](mailto:kasra@e-kasra.com) or call KASRA at our relatively new phone number of 925-685-1313, and we will do what we can to help.

This message is being sent to KASRA members by email only. If you know of other retirees who do not use email but who would want to have the above information, please share it with them.

*This letter was distributed by e-mail on September 30. The final paragraph has been updated to reflect the most recent VEBA Plan enrollment figures.*

**Dear Retirees and Surviving Spouses:**

A number of you have inquired why eligible retirees, spouses and dependents who have elected to receive and are receiving COBRA or Bankruptcy COBRA health care continuation coverage from Kaiser cannot participate in the VEBA Plan until such COBRA coverage is discontinued or terminated.

One of Kaiser's key objectives in its reorganization proceedings has been the elimination of health care benefits for retirees. COBRA generally requires an entity in bankruptcy, such as Kaiser, to offer health care continuation coverage under COBRA to its eligible retirees, spouses and dependents if the bankrupt entity continues to offer group health care benefits to any of its active employees.

COBRA is intended to form a bridge between coverage under a former employer's group health plan and coverage under any new group health plan, and allows the former employer to discontinue COBRA health care continuation coverage in the event that the former employee, the spouse, or the dependent (as the case may be) becomes enrolled in a new group health plan.

Although the VEBA Plan currently is unable to provide benefits that are in any way comparable to or as valuable as the COBRA health care continuation coverage benefits or the benefits customarily provided under any other comprehensive health care plan, the VEBA Plan is nevertheless a group health care plan.

The Retirees' Committee has attempted on numerous occasions to get Kaiser to agree to waive any right it may have to discontinue COBRA health care continuation coverage based upon enrollment in the VEBA Plan, but Kaiser has steadfastly refused to do so. While Kaiser has indicated that it will not exercise any such right at this time, the prospect that it might do so at any time following its reorganization puts valuable COBRA health care continuation bene-

fits in peril of forfeiture if recipients become enrolled in the VEBA Plan. In order to protect the rights to receive COBRA health care continuation benefits, the VEBA Plan does not permit enrollment of anyone continuing to receive such benefits.

A COBRA health care continuation coverage recipient is free at any time to discontinue his or her COBRA coverage and, if eligible, to then enroll in the VEBA Plan. However, given the limited and uncertain benefits the VEBA Plan is currently able to provide, each recipient of COBRA health care continuation coverage should think very carefully before discontinuing his or her COBRA coverage.

We are sending this message to those retirees who have e-mail. It will be repeated in the November newsletter. Meantime, if you know of any retirees who do not use e-mail, we would appreciate your sharing this information with them.

A reminder: Eligible retirees/surviving spouses need to mail in their completed VEBA enrollment form so that it is received prior to December 31, 2005. As of October 31, 3,044 salaried retirees were eligible to participate in the VEBA Plan. Only 1,228 retirees (approximately 40%) have enrolled so far, with no enrollments currently pending. Approximately \$275,000 in benefits have been paid to date. Once enrolled, you will have until December 31, 2006, to file claims for VEBA reimbursement of health care premiums paid during 2005.

## HURRICANES KATRINA & RITA HIT KASRA RETIREES

### Chalmette Lunch Bunch to hold December 6 gathering at Doug's Restaurant

Hurricane Wilma swept through Florida last month, impacting KASRA retirees who live there. This story, however, is about two earlier hurricanes. In the days following Hurricanes Katrina and Rita that occurred in late August and early September, this editor began to receive emails from concerned KASRA members. Many of our KASRA retirees who lived in the hardest-hit areas of Alabama, Louisiana, Mississippi and Texas lost their homes and belongings. While some have since returned to the affected areas, more remain displaced in other cities and states. Many sought temporary refuge in the homes of their sons or daughters, or other family members who live elsewhere.



They say if you tell two people something they will turn around and tell two more people until pretty soon you have a sizable network going. Well, with a click of his computer mouse, **Chuck Schimmel** of Slidell, LA, set up an informal communication network among retirees entirely by email. Chuck is this editor's email contact for the Chalmette Lunch Bunch and promptly responded to her inquiry about **Sherman Faught**, Chalmette's other lunch coordinator. This was in early September, and Chuck would not hear back from Sherman until nearly three weeks later. In the meantime, Chuck added the editor's email to his listserve (group of email users). We began to receive a steady stream of updates from Schimmel, apprising us of the individual whereabouts of KASRA retirees as the information became available.

Major disasters occur with regularity around the world

but seldom do they hit so close to home. For this reason, we feel it important to share some of Chuck's on-line journal when he and his wife Jackie returned to Slidell to pick up the pieces of their lives. We have purposely not edited his notes because we believe you will appreciate their authenticity.

9/18/05

*Good Day,*

*This morning Jackie & I took a tour around Slidell.*

*Not because we needed to be there, but there was/is so much incorrect information we wanted to see for ourselves.*

*First -- the absence of any check points, or for that matter, police/guard/sheriff etc. presence. Contractors running wild with no guidance, each one trying to get ahead of the other. No traffic control. Pretty chaotic & not so safe. The first element of organization, command & control is sorely lacking. Not too many stories of looting or such, although, our son & daughter-in-law were robbed in their primary residence in Olde Towne -- 3 blocks from the police station. They probably attribute that to: stuff happens.*

*The area closest to the lake (south) pretty much gone, either totally or extremely heavy damage from wind and water. Areas like Rat's Nest Road; Carr Drive; Highway 433; Eden Isles; Oak Harbor; Highway 11 (Pontchartrain Drive): Westchester in to Olde Towne Slidell. Olde Towne Slidell up to Gause Boulevard, flooding and extensive tree damage. North Slidell, where we live, no flooding but extensive tree damage. The areas off of Military Road, French Branch Estates, Quail Ridge; some of Cross Gates, etc. flooding & extensive tree damage.*

*In many instances it will be more cost effective to bulldoze what remains rather than to rehab what exists. Words, or pictures, for that matter, cannot begin to do justice to the situation. They are sights beyond description.*

*However, in light of all the confusion, most areas have power, gas, water & sewer as well as routine garbage pick up. Mail service is being restored. Public schools will restart on 3 October. Some private and parochial schools have restarted or will begin tomorrow.*

*Church based groups have been providing meals and other basic necessities. Military is handing out MRE's, water & ice. For the most part "official" vehicles like to use their flashing lights, a whole lot. All in all, a pretty bad situation is improving.*



9/20/05

*Today, more police presence. FEMA has established a site at John Slidell Park. Restaurants, barber shops opening, including Young's Steak House. Regular gas, limited supply but premium is no problem.*

*Buy stock in "blue poly tarps," it is everywhere. For those of you with fireplaces, please stop by and help yourself to our wood pile -- it is free for the pick up. From the auto license plates half the states of Texas, Florida, Georgia and Missouri must be here. Local school football teams, soccer teams, etc., starting to practice.*

*I do not have a death toll as very little is being released. However, the initial estimates of numerous (in the 100s) of dead appears to be unfounded.*

9/22/05

*Good Afternoon,*

*I just finished a conversation with a district fire commissioner. For what it is worth, here is what he said regarding the Slidell area. He confirmed, what we have suspected, the body count is being suppressed. He did not know why.*

*Presently, there are a number of recovery teams with dogs searching through rubble and debris in the adjacent marshes & bayous. He indicated that not a lot of bodies are being found but they are uncovering remains. The parish coroner has been able to do positive identification on most, if not all, of the deceased. As bad as that might be, it will, at least, give some sort of closure to their families.*

*He also said there had been several cases of arson in the fire district. Mostly attributed to frustrated homeowners who lost out to flooding and had no flood insurance.*

*The FEMA contractors are doing a good job systematically clearing the piles of debris from the streets.*

*Rather than sell the pines to pulp processors, FEMA is burning them -- go figure.*

*Just started to rain, hopefully not in the quantities predicted.*

*Hope & pray the Southwest Louisiana & East Texas area is not badly hit (by Hurricane Rita).*

If there was any question about the power of the internet, those doubts vanished with the almost overnight creation of a new community of KASRA retirees within our larger family. 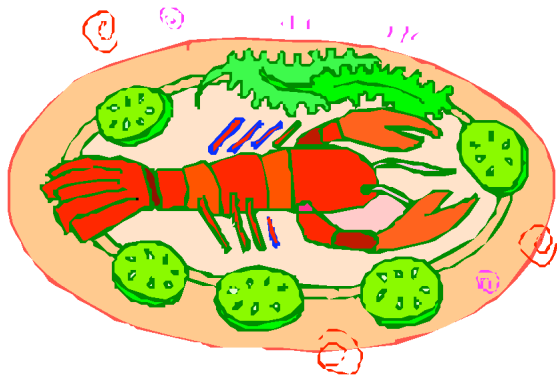
