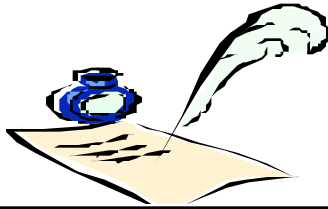

Retiree News

Dear Fellow Retiree:

My message in this issue will be devoted almost entirely to the Kaiser Aluminum Salaried Retirees VEBA Plan.

By now, all salaried retirees/surviving spouses -- except those who signed up for COBRA medical coverage -- should have received a mailing from the Kaiser Aluminum Salaried Retirees VEBA Plan. The package includes a three-page letter dated July 27, 2005, from the VEBA Trustees; a 15-page Summary Plan Description; a two-page Q and A; a two-page VEBA Plan Qualified Benefit Reimbursement Request Form for Plan Year 2005 (and reply envelope); a two-page VEBA Plan Enrollment Form (and reply envelope); and a six-page Notice of Privacy Practices.

If you have not received the mailing, if the package does not include all of the above-mentioned enclosures, or if you have any questions regarding the package and the subjects addressed in it, you should contact the VEBA Plan's Third Party Administrator: Thomas P. Corcoran at 800/339-3479 (in California only) or 925/798-2550 (outside of California). If you prefer to communicate by mail, the address is: Thomas P. Corcoran, Professional Insurance Consultants, Inc., P. O. Box 4026, Concord, CA 94524. It is important that you contact Mr. Corcoran's office rather than KASRA.

Please note that if you elected to receive group medical benefit continuation coverage from Kaiser under COBRA or under Bankruptcy COBRA, you did not receive the VEBA mailing and are not eligible to participate in the VEBA Plan until such coverage is discontinued or terminated.

As you will see from a careful reading of the materials, the VEBA Trustees have decided to declare a benefit of up to \$500 per family unit for 2005. In order to claim the benefit, eligible retirees, spouses and dependents must be enrolled as participants in

the plan prior to December 31, 2005, AND the family unit representative must submit, prior to December 31, 2006, a qualified benefit reimbursement request requesting reimbursement of up to \$500 in health care premiums paid during 2005, together with proof of payment and proof of coverage.

If you have not already read the materials carefully, you need to take the time to do so. And, you need to make sure you mail in your enrollment form so that it is received prior to December 31, 2005. You have up to one year after that to submit your request for reimbursement of up to \$500 in health care premiums paid during 2005.

As you know from previous newsletter messages, so long as the company remains in Chapter 11 reorganization, it is obliged to make advances of \$300,000 a month to the VEBA Trust. If the company emerges from bankruptcy before it has made advances totaling \$5,220,000, it is obligated to contribute the unpaid balance on emergence to the extent it can. If the company has made advances of more than \$5,220,000 before it emerges from bankruptcy, the excess contributions will be credited and offset against future profit-sharing contributions, if any. Including an initial \$200,000 advance payment, the advances to the Trust through August total \$4,700,000. The funds are being deposited by the Trustees in the Union Bank of California and are earning interest.

Each of us owes a debt of gratitude to the VEBA Trustees, who serve voluntarily, for the many hours they have devoted to establishing the Trust and preparing for its first reimbursement distribution. Each year, they will determine the amount and timing of benefits, if any, for that year. Although the company contributions into the VEBA do not allow the VEBA to fund retiree medical benefits that are in any way comparable to the retiree medical benefits that were terminated as of May 31, 2004, the partial reimburse-

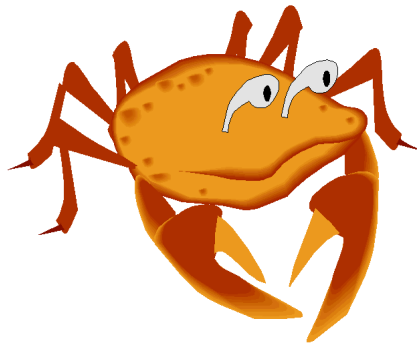


of year when so many of you send in news. Please be patient as we publish as much as space permits. If you don't see your item here, be sure to check the next issue.

as they are about to shed their old shells. He shares the wealth with friends and family, including four of his six children who live nearby.

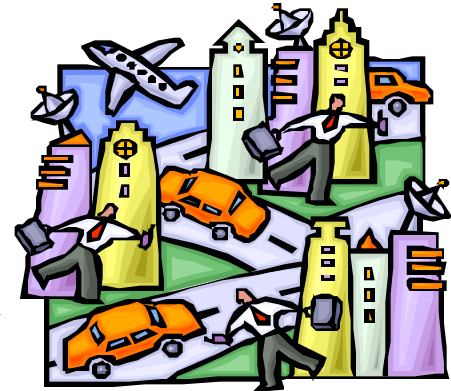
VALCO retiree **Leon Buckles** of Spokane, WA, and

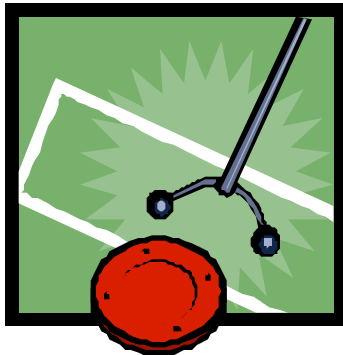

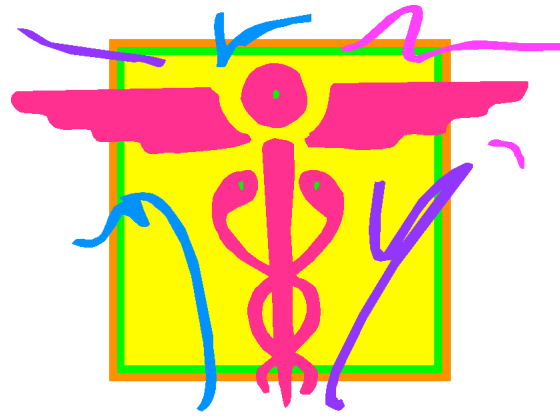

The Three Signs of a Stroke

Sometimes symptoms of a stroke are difficult to identify. Unfortunately, the lack of awareness spells disaster. The stroke victim may suffer brain damage when people nearby fail to recognize the symptoms of a stroke. Now, doctors say a bystander can recognize a stroke by asking three simple questions:

1. Ask the individual to **SMILE**.
2. Ask him or her to **RAISE BOTH ARMS**.
3. Ask the person to **SPEAK A SIMPLE SENTENCE**.

If he or she has trouble with any of these tasks, call 911 immediately and describe the symptoms to the dispatcher.

KASRA's **Evo Alexandre** of Moraga, CA, recently distributed this information to our members who have an email address. **Larry Nuzum** of Pinetop, AZ, passed it along to the Navopache Regional Medical Center, the local hospital where Larry and his wife, Lee, volunteer. The hospital published the information in its newsletter and another hospital volunteer was able to put it to good use. The volunteer went to visit a patient and noticed that he looked strange. The volunteer asked the patient if he could smile. The patient shook his head. Can you raise both arms, the volunteer asked. Again, the patient shook his head. The volunteer immediately located a nurse who confirmed the patient had indeed suffered a stroke, and he immediately received medical assistance.

ments that the VEBA will be able to make should be of at least some help.

There are several other, non-VEBA items of interest:

- A number of limited objections have been filed by various parties to portions of the Disclosure Statement for Kaiser's Joint Plan of Reorganization, including one filed by the Official Retirees Committee. The Committee seeks to require Kaiser to reveal, as part of the Disclosure Statement, the identity of all persons proposed to be directors of the reorganized company, together with all direct or indirect connections they may have to anyone who will hold more than 20 percent of the reorganized company's common stock. In general, the objections filed indicate that, while progress is being made on proposed changes to the Disclosure Statement, the Statement is not yet ready for approval. The Bankruptcy Court is expected to rule on these limited objections in the near term.

- KASRA members have elected two new directors, Steve Abernathy and Carlos Xavier, to an initial three-year term and have re-elected four current directors, Dick Kauffman, Alan Longmuir, Ron Radakovich, and Steve Ringwood, to a second, three-year term. Thank you for voting and thanks to the elected individuals for their willingness to serve.

- KASRA has moved its office from Lafayette to Pleasant Hill, California. We are retaining the Lafayette Post Office Box address and you should continue to use it for all correspondence to KASRA. That address is Kaiser Aluminum Salaried Retirees Association, P. O. Box 1171, Lafayette, CA 94549. KASRA does have a new phone number. It is 1-925/685-1313. KASRA's phone was out of service for about a week during the recent move. If you tried to reach us then, our apologies for the inconvenience.

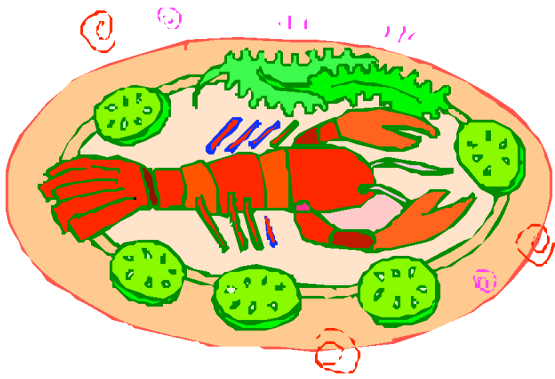
