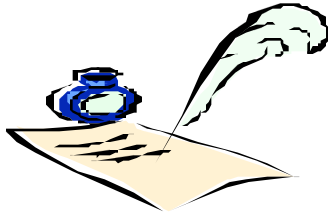

## Retiree News

### Dear Fellow Retiree:

This will be my final newsletter message to you. It has been my pleasure to serve on the KASRA Board for six years and to be your president for the last five. In short, "It ain't been dull!" I'll have more to say about this toward the end of my letter. But, first, I want to bring you current on some recent developments.

As you know by now, Kaiser Aluminum emerged from bankruptcy in early July. The "new" Kaiser Aluminum is smaller and different from the company we were a part of. The company no longer mines bauxite or produces alumina, and its only primary aluminum investment is a 49% interest in the Anglesey smelter in Wales. It now operates eleven plants in the United States and Canada for the production of sheet, plate, extrusions, forgings, rod, bar and tube products for aerospace and high-strength, general engineering, and automotive and custom industrial applications. The company now has about 2,000 employees. Although we retirees certainly have had our differences with the company the past several years, it is in our best interests that the new version succeed because our VEBA holds stock in the company and is entitled to share in the profits if and when certain targets are met. Beyond that, I personally like the notion that a company with the name of Kaiser Aluminum continues, even though it is a very different company from the one we worked for.

There have been a number of developments relating to the VEBA:

- Kaiser Aluminum's Plan of Reorganization

became effective on July 6. Under terms of the plan, the VEBA was entitled to receive 1,940,100 Kaiser Aluminum shares of common stock on that date. Prior to the effective date, the VEBA was able to sell its rights to receive 940,233 of those shares for gross proceeds of \$31,702,578. The first of these two sales was reported in my July newsletter message. The VEBA received the remaining 999,867 shares to which it was entitled. The two sales, along with future sales of the remaining shares under favorable market conditions, advance two principal objectives of the VEBA - providing necessary liquidity for the payment of benefits and administrative expenses over time and allowing diversification of its investment portfolio.

- In June, the VEBA received the final monthly cash contribution of \$300,000 from Kaiser Aluminum to be made while it was in reorganization, bringing the total amount of such contributions to \$7,700,000.

- As previously reported, the VEBA Trustees declared a Qualified Benefit for 2006 of up to \$1,500 per family unit. The amount declared can be used to reimburse medical insurance premiums paid in 2006 by retirees or surviving spouses who have enrolled in the VEBA Plan no later than December 31, 2006 and who have filed the necessary reimbursement form prior to December 31, 2007. In addition to declaring a Qualified Benefit for 2006, the Trustees declared a "make-up" benefit for those family units who did not receive their full \$500 Qualified Benefit for 2005 because one or more individuals in that family unit received COBRA or Bankruptcy COBRA benefits from Kaiser. The additional Qualified Benefit is limited to \$500 per family unit, less the total amount paid by way of reimbursement of health care premiums paid by or on behalf of participants in that family unit for 2005.

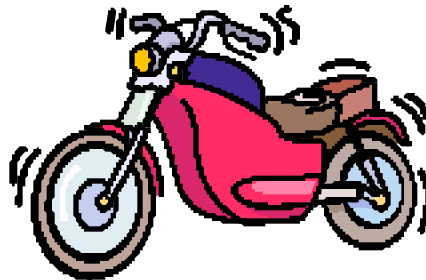

■ After some unexpected delays, the VEBA completed three separate 2006 benefit materials mailings. One, to previously excluded COBRA individuals; another, to all other eligible but not yet enrolled individuals; and a third, to enrolled participants. 
■ A final note on the VEBA. **There is absolutely no reason not to join.** So, if you have not, I urge you to do so. Only by joining can you be eligible to receive reimbursements such as the up-to-\$1,500 declared for 2006.

Now, for some concluding thoughts. When I first came on the KASRA Board six years ago, few if any thought the company would go into bankruptcy in less than two years. But it did, with the result that retiree medical and life insurance benefits were terminated. During this time, your Board, past members of the Board, the Official Retirees' Committee, and the VEBA Trustees have worked to do everything they could to represent and protect your interests. The stock ownership and the VEBA and the benefits it will provide are a result of these efforts. None of this would have been achieved without the existence of a strong membership organization like KASRA and the support you have provided.

It has been a privilege to be associated with the many who volunteered endless hours to bring us to where we are today. It also has been a pleasure and privilege to visit with so many of you - in person and over the phone. My thanks to all of you. Although I and others who have served six years (two terms) are term-limited off the board, I will continue to be available to the board if and as called upon.

A new president and other officers will be elected at KASRA's annual meeting in September. Your association is in good hands and deserves your continued input and support.

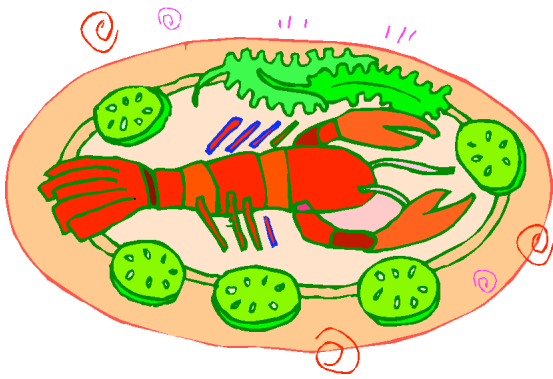
